



AGREEMENT FOR INTERINSTITUTIONAL COLLABORATION CONVENIO Nº 565-2014-MINEDU

BETWEEN

THE MINISTRY OF EDUCATION OF PERU AND MONASH UNIVERSITY

This document certifies the Agreement of Interinstitutional Cooperation for the implementation of Graduate Scholarships between **THE MINISTRY OF EDUCATION OF PERU**, with RUC N° 20131370998, hereafter THE MINISTRY, with legal address in Calle Del Comercio N° 195 – San Borja – Lima 41 – Perú, represented by the Executive Director of the National Program of Scholarships and Educational Credit (PRONABEC in Spanish), Dr. Raúl Choque Larrauri, identified with DNI N° 23266921 and appropriately authorized to celebrate this agreement as stated in the Ministerial Resolution N° 014-2014-MINEDU, and **MONASH UNIVERSITY** with the address at Wellington Road, Clayton, Victoria 3800, represented by the President and Vice Chancellor, Professor Margaret Gardner, duly authorized to sign this agreement according to the Monash University Act, 2009 (Vic), under the terms and conditions expressed as follows:

FIRST: THE PARTIES

- **1.1.** THE MINISTRY is the instance of THE MINISTRY in charge of defining, directing and articulating policies regarding education, culture, recreation and sports in accordance with the general policies of the State.
- 1.2. PRONABEC, is the Executive Unit N° 117 in charge of the design, planning, managing, monitoring and evaluating of scholarships and educative credits for higher education with the objective of contributing to equal opportunity in the access of low income students and professionals with academic excellence to programs of study as well as guaranteeing their permanence, culmination and obtaining of their degree tittles.
- 1.3. PRONABEC, subsidizes,
 - a. Graduate studies for professionals with high academic performance and insufficient economic resources in Eligible International Higher Educational Institutions and Universities whom must be ranked among the first four hundred (400) at least once in the five years prior to the respective call in the following rankings: QS World University Rankings, Academic Ranking of World Universities (ARWU), Times Higher Education World University Rankings, and focusing on studies related to Peruvian scientific and technological development.
 - b. Tuition, fees, study materials, English language course, if necessary maximum 10 weeks; insurance with health, accident, life and repatriation coverage, research work, certification (administrative costs for obtaining the relevant degree or equivalent), monthly allowance for food, lodging and local transportation and others than PRONABEC determines by the rules of each call according to budget availability; international transport (only at the beginning and end of the academic program), except the repetition of unapproved courses.
- 1.4. MONASH UNIVERSITY being ranked 70 according to QS World University Rankings, ranked in the top 101-150 according to the Academic Ranking of World Universities (ARWU) and 83 according to the Times Higher Education World University Ranking) in the year 2014/2015. Monash University is Australia's largest university and one of the most researchers active with over 63,000 students studying in Melbourne and at one of its international campuses.















SECOND: BACKGROUND

The Agreement of Interinstitutional Cooperation, between THE MINISTRY and MONASH UNIVERSITY, exercises the intention of the parts to strengthen their efforts to increase the offer of graduate scholarships with the objective of boosting the human capital with an adequate training, refinement and research promoting competitiveness and scientific and technology development for Peru.

THIRD: LEGAL FRAMEWORK

- 3.1. Law 29837 creates the National Scholarship and Academic Loans Program.
- **3.2.** Supreme Decree N° 013-2012-ED that approves the Rules and Regulations of the Law 29837, modified by Supreme Decree N° 008-2013-ED, dated September 21, 2013.
- 3.3. Ministerial Resolution N° 0108-2012-ED that approves the Operations Manual of PRONABEC.
- **3.4.** Ministerial Resolution N° 014-2014- MINEDU: Delegates of Powers and Duties to the Executive Director to sign this kind of agreements.

FOURTH: GENERAL OBJECTIVE

The general objective of this agreement is to improve the efforts of THE MINISTRY in building advanced human capital through the awarding of scholarships for graduate studies programs in order to promote the scientific, academic, economic, social and cultural development of the country.

FIFTH: SPECIFIC OBJECTIVE

To promote the access of Peruvian students and professionals with excellent academic performance and insufficient economic resources to the graduate programs offered by MONASH UNIVERSITY through the financing, by THE MINISTRY, of up to 50 students every year in Master and Doctoral programs related to Science and Technology.

The length of the Graduate Scholarships is determined by the program of choice according to the parameters of MONASH UNIVERSITY in relation to the Master and Doctoral programs specified in **Annex 1** of this agreement, taking into consideration the areas prioritized by THE MINISTRY, up 2 (two) years for Masters and 4 (four) years for Doctorates.

SIXTH. – COMMITMENTS OF THE PARTIES

6.1. COMMITMENTS OF MONASH UNIVERSITY

MONASH UNIVERSITY assumes the following commitments:

- 6.1.1. Give a corporate rate for application costs and registration; tuition fees for approved 4th year Doctoral candidates, and all educational services provided by MONASH UNIVERSITY in Masters and Doctoral studies. For fiscal year 2015 (January-December) these costs are specified in Annex 2 of this agreement. Annually, at the beginning of every year, MONASH UNIVERSITY will inform THE MINISTRY these costs, which are the lowest unsubsidized of MONASH UNIVERSITY.
- 6.1.2. Grant the acceptance letter to every Peruvian professional that meets regulations, policies procedures and criteria set by MONASH UNIVERSITY. With this letter this professional will compete to get a postgrade scholarship in THE MINISTRY. Each successful Peruvian professional who wins a scholarship will be a Ministry's scholarship holder ("Scholarship Holder"). For the prevention of doubt, the terms of this agreement will only apply to the















Scholarship Holders and not to other Peruvian professionals who are granted an acceptance letter.

- 6.1.3. Facilitate to the best of its ability, the documentation needed to obtain the Student Visa, for the entire length of the graduate program chosen by the Scholarship Holder. MONASH UNIVERSITY declares to know than this visa, after reaching the title shall not be renewed by any reason, and acknowledges the obligation of the Scholarship Holders to return to Peru to accomplish their "Peru Commitment Service", to share in their hometown the knowledge acquired. In that sense, MONASH UNIVERSITY should avoid making any kind of offer to Scholarship Holders to work with MONASH UNIVERSITY or encourage them in any way to stay to work in Australia after have ended their postgraduate studies.
- 6.1.4. Provide tutoring and academic and psychological mentoring as well as support and access to counselling services to the Scholarship Holders during their graduate studies period.
- 6.1.5. Send to THE MINISTRY, at the end of each teaching period, together with the invoice for the next semester as specified in Annex 2.
 - One academic transcript for each Scholarship Holder of the concluded semester.
 - Enrolment report of the incoming semester.

THE MINISTRY will ensure that all THE MINISTRY's Scholarship holders will sign the authorization indicated in Annex 3.

- 6.1.6. Provide to each Scholarship Holder entry into the 5 week INTRODUCTORY ACADEMIC PROGRAM (IAP) at the Language Center of MONASH UNIVERSITY, before starting their graduate studies as further described in Appendix I of this agreement
- 6.1.7. Provide to THE MINISTRY, the assistance to install in the institutional electronic portal of PRONABEC a direct link to the Website of MONASH UNIVERSITY in order to facilitate the access to the information concerning the Master and Doctorate programs offered by MONASH UNIVERSITY, indicated in Annex 1, authorized by the educational Australian authorities and officially accredited internationally.
- 6.1.8. Provide information and advice about room and board to Scholarship Holders.
- 6.1.9. Encourage and give the facilities to Scholarship Holders to start their research work from the beginning of their studies in order to have it done by the end of their academic programs to achieve their respective titles.
- 6.1.10. Facilitate a well-equipped research space to each Scholarship Holder of THE MINISTRY in order to guarantee the normal development of their research activities.
- 6.1.11. Not enrol in the next academic term the Scholarship Holder who fails to meet to MONASH UNIVERSITY'S requirements set out in its statutes, regulations, policies and/or procedures (causal loss of scholarship) and immediately inform THE MINISTRY to take necessary
- **6.1.12.** Communicate to THE MINISTRY any applying for suspension of studies.



6.2. COMMITMENTS OF THE MINISTRY

THE MINISTRY, through PRONABEC, commits to:

Cover upfront the tuition costs of each Peruvian scholarship holder. The annual costs must be informed to THE MINISTRY by MONASH UNIVERSITY. THE MINISTRY, prior to the enrolment of the Scholarship Holder, will pay the tuition costs of incoming semester within 30 days of the date of invoice from MONASH UNIVERSITY. MONASH UNIVERSITY will submit an invoice for fees each semester. In case of new Scholarship Holders, the payment, exceptionally and with MONASH UNIVERSITY'S prior approval, could be done in a major













term, according to schedules for publication of results of every scholarship contest and, inclusive, after starting classes, with a previous coordination.

- 6.2.2. Grant an annual stipend for the concept of living expenses.
- 6.2.3. Grant an annual stipend for the purchase of academic materials.
- 6.2.4. Provide roundtrip flight tickets to each Scholarship Holder: Lima - Melbourne (at the beginning of the academic program) and Melbourne - Lima (at the end of the academic program).
- 6.2.5. Cover the degree certification costs and the rest of benefits indicated in number 1.3.2 ut supra.
- 6.2.6. Provide adequate health insurance cover to each Scholarship Holder (health, accidents, life and repatriation).
- 6.2.7. Provide a stipend to each Scholarship Holder, including who enrols in the five weeks Monash Introductory Academic Program, offered only to students who have met the academic and English requirements to study at Monash University, therefore they have been offered an unconditional offer (according to Appendix 1).
- 6.2.8. Communicate to MONASH UNIVERSITY the name of Scholarship Holders designated by THE MINISTRY before starting graduate or English studies, accordingly.

6.3 **COMMON COMMITMENTS**

- Elaborate a joint program every year aiming to achieve the objectives of the commitments contemplated on this agreement.
- 6.3.2. Evaluate and inform the results of the cooperation achieved, identifying the inconveniences and the possible improvements in the execution of this agreement.

SEVENTH: THE FINANCING

THE MINISTRY will cover the costs of the concepts indicated in numeral 6.2 and MONASH UNIVERSITY will assume the costs indicated in numeral 6.1 of the Sixth Article, with the objective that the Peruvian Scholarship Holders can access, stay and finish their studies in MONASH UNIVERSITY and the completion of their degree. The financing corresponding to THE MINISTRY is granted according to the Budget assigned annually by the Public Budget Laws of the country and the Law N° 28411 - General Law of the National Budget System of Peru.

INTERINSTITUTIONAL COORDINATION EIGHTH:

For the adequate follow up, supervision and monitoring in compliance of the commitments established in this agreement, the parties agree to assign as Interinstitutional Coordinators, according to the functions exercised in the implementation of this agreement, the following officials:

By THE MINISTRY

THE MINISTRY, through PRONABEC, and MONASH UNIVERSITY shall substitute their Interinstitutional coordinators when appropriate.

The substitution must take effect starting the seventh day after the reception of the letter of substitution given by the counterpart.

NINTH: LENGTH OF THE AGREEMENT VALIDATION

The length of validation of this agreement is five (05) years, starting from the date of subscription.

Finalized the length of validation, the commitments assumed by the parties will remain in effect until the total compliance and execution of the pending commitments in progress.

TENTH: AGREEMENT MODIFICATIONS

Any modifications, restrictions, broadening or extension of this agreement can be done through mutual consensus of the parts and must be formalized by Addendum which will become part of this agreement.



ELEVENTH: SOLUTIONS TO CONTROVERSIES

Any controversies, discrepancies or demands derived from this agreement, including the ones concerning its expiration, nullity, execution, compliance or interpretation shall be settled by THE PARTIES through mutual consultation between inter-institutional coordinators acting in good faith and in accordance to their common objectives within a reasonable period of up of sixty days.



In case the controversy persists, the parties express their will to submit to awareness or equity arbitration, which will be unique, definitive, unchallengeable and binding on the parties and may not be appealed to the judiciary or to any administrative instance.

To this end, either party may request the Arbitration Center of the Lima Commerce Chamber to appoint one among its skilful members. After assuming the charge and receiving the parties positions, the resolution shall be issued within fifteen working days.

Each Party will continue to perform this agreement despite the existence of a Dispute or any proceedings under the above paragraph of this clause.



TWELFTH: COMPLIANCE WITH LAWS

- **12.1.** THE MINISTRY understands that MONASH UNIVERSITY must conform to the *Information Privacy Act* 2000 enacted by the State of Victoria, Australia. This Act may, in certain cases, restrict the transfer of scholarship holders' personal information from MONASH UNIVERSITY.
- **12.2.** THE MINISTRY understands that MONASH UNIVERSITY must also conform to appropriate requirements of the Education Services for Overseas Students (ESOS) Act 2000 enacted by the Government of the Commonwealth of Australia, and the National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students.
- 12.3. THE MINISTRY undertakes not to engage in any act, which may result in MONASH UNIVERSITY contravening an Australian Sanctions Law. For the purposes of this article, Australian Sanctions Law











means any law prohibiting or restricting dealings with proscribed states, persons or entities or seeking to prevent the proliferation of weapons, including but not limited to laws implementing the sanctions imposed by the United Nations Security Council.

THIRTEENTH: FINAL DISPOSITIONS

- 13.1. The parties subscribing to this agreement, expressly state that their respective residences are the addresses mentioned in the introduction to this document, in which each other will be passed validly communications and / or notifications as necessary. Any variation of these addresses will be effective the tenth business day of being notified in writing to the other party.
- 13.2. All communications shall be valid and effective if done writing, sent and received via fax, institutional e-mail, certified mail or notarized communications, remitted between those who subscribe this agreement and between Inter Institutional Coordinators, designated by the parties at the eighth clause ut supra.
- **13.3.** This agreement may be terminated by either party. As such:
 - a. When there are current Scholarship Holders enrolled at MONASH UNIVERSITY at the time of the termination notice, the decision shall become effective from the conclusion of the current academic period. Otherwise, at thirty day after received the resolution communication.
 - b. The resolution does not affect the activities and obligations that the parties are developing, which should continue to be met until complete implementation, as appropriate.
 - c. Notwithstanding the termination of this agreement, THE MINISTRY must pay MONASH UNIVERSITY any outstanding fees for Scholarship Holders legally due under this agreement.
 - d. If it is not possible to transfer a Scholarship Holder to another university to complete his/her studies, MONASH UNIVERSITY will make all reasonable efforts to assist THE MINISTRY in finding an alternate arrangement for the Scholarship Holder in case he/she accepts the transference. Otherwise the Scholarship Holder will remain in MONASH UNIVERSITY until finishing postgraduate studies, in whose case commitments of counterparties will remain exclusively respect of this Scholarship Holder and will not make any Contests to grant more scholarships to postgraduate studies in MONASH UNIVERSITY.
 - e. The parties shall take the necessary measures to avoid or minimize any prejudice, both among themselves and Scholarship Holders.

In absolute conformity, THE PARTIES proceed to subscribe this agreement in two sets of 03 original copies each, one in Spanish and the other in English and both equal in content and authenticity.

APPENDIX I

Research Classified Degrees:

MONASH UNIVERSITY will provide benefits to THE MINISTRY's Scholarship Holders enrolled in research classified degrees (for Masters and PhD programs) as follows:

- a. Tuition fee scholarship to Scholarship Holders enrolled in MONASH UNIVERSITY PhD program for up to 12 months during the fourth year of enrolment. This tuition fee scholarship will only be granted to Scholarship Holders who are able to provide evidence of satisfactory progression and will submit their thesis during the fourth year. It will be paid in quarterly amounts subject to satisfactory progression during the previous quarter.
- Scholarship Holders undertaking research classified degrees will also be given access to the Monash Skills Essentials seminars and workshops. Topics cover funding and academic opportunities, data management, intellectual property, statistics, writing, presenting and publishing your thesis, completing it on time and more.
- c. Statistical Support: Scholarship Holders undertaking research classified degrees will be eligible for up to 10 hours of free statistical assistance over the course of their candidature.
- d. Travel grants: Research classified degree Scholarship Holders will have access to travel grants to assist with the travelling expenses of who wish to interact with researchers, undertake data collection, learn new techniques, pursue research in specialist archives, collections, undertake field trips, surveys and interviews, and to utilize specialist equipment or resources not available at Monash University.

Postgraduate Coursework Classified Degrees

MONASH UNIVERSITY will provide a 10% reduction on the annual tuition fees to Scholarship Holders enrolled in postgraduate coursework classified programs. The reduction does not apply to Scholarship Holders enrolling in research classified degrees such as the PhD or Masters by research.

Introductory Academic Program

Monash College will provide up to five (5) tuition free places into the five weeks Introductory Academic Program (IAP). This program will assist scholarships holders to enhance their academic skills, preparing for the reading, writing, speaking, listening, note taking and research that they will undertake in the award program. Please note the IAP runs twice a year before the start of each semester.
