2. Observation period

Observation with the magnetometer is continued from April 2011 to March 2012, and this agreement is automatically renewed on April First every year unless one side does not wish to continue. When one party does not wish to renew it, they shall give a notice to other party by two months before the last day of observation period at the latest.

3. Operational costs

IGP will provide the basic expense for operations in the observation site. Kyushu University will pay annual fee of US\$ 1,080- (US\$ 90-/month x 12 months), for the use of the facilities, to IGP, Peru.


