Diplomatic Vehicle Auction

The Peruvian Embassy in Singapore is selling a very well-maintained vehicle Toyota Camry, manufactured in 2012 by auction to be carried out **on 5 July 2023**. The details are as follows:

- Year of Production: 2012
- Capacity: 2.0
- Mileage (KM): 89,000 km
- Starting Price (SGD): 1,722.54
- Colour: Black

In accordance with the procedures from the Ministry of Foreign Affairs of Peru, to participate in the auction, the steps are as follows:

1. Acquire the administrative guidelines ("bases administrativas")_by making a payment of SGD 4.00 (four Singaporean dollars) to the following bank account:

Send the above transfer slip to the two email addresses below with the subject "Vehicle auction – Toyota Camry" **until 4 July 2023**:

Once your payment is received, a receipt for the administrative guidelines and the link for the auction will be sent to you.

2. Bidders must submit their offers (only one per bidder) **on the day of the auction, 5 July 2023, before 11.00 hrs** by one of the following formats:

a) Hand-delivered closed envelope with the subject "Vehicle auction – Toyota Camry" with the following information:

- Name and identification of the bidder.

- Receipt for the administrative guidelines (mentioned in step 1).
- Clearly state your offer for the vehicle in SGD.

b) Email to peru@embassyperu.org.sg with the subject "Vehicle auction – Toyota Camry" with the following information:

- Name and identification of the bidder.
- Receipt for the administrative guidelines (mentioned in step 1).
- Clearly state your offer for the vehicle in SGD

4. The auction will be conducted on-site at the Embassy of Peru (390 Orchard Road, unit 12-03, Singapore 23887) and online on **5 July at 11.00 am**. The link will be provided along with the receipt for the administrative guidelines. However, please note that only those who have submitted an initial offer can bid during the auction. Bidders participating online must have audio and camera on.

The minimum bid amount is SGD 1,722.54.

5. The diplomatic vehicle has been exempted from taxes by the MFA, which can be applied to bidders with diplomatic privileges and exemption from COE (Certificate of Entitlement) in Singapore (subjected to MFA approval).

6. The vehicle will be sold to the highest bidder. The payment conditions are as follows:

- The successful bidder must make the bank transfer of 20% of the offer. The rest 80% payment will be within three working days after the bidding.
- Payment can be made via bank transfer or cheque.

Once the payment is received, the Embassy will make the necessary arrangements for the handover, following local regulations.

7. Please note that the vehicle sale is final and sold on an as-is basis. There are no warranties provided, and returns are not accepted. The Embassy of Peru will not be responsible or liable for the vehicle after the sale. The Embassy reserves the right to halt or cancel the sale at any stage prior to payment.

8. All expenses related to the transfer of ownership, registration, insurance, and any other expenses are the bidder's responsibility.

9. Any controversy or dispute during the bidding will be solved by the Head of Mission of the Embassy of Peru, whose decision cannot be appealed.
