Article 7 Work Plan

The Parties agree to formulate a Work Plan annually based on the areas or activities referred to in Articles 2 and 3 of this Cooperation Agreement. The Work Plan shall be approved by the coordinators of the Parties, within a period of no more than thirty (30) working days after the date of signing the Cooperation Agreement. The Work Plan will be an integral part of this Cooperation Agreement and will prioritize the actions and goals agreed upon, as well as those responsible for them.

Article 8 Disclosure of Information

The Parties agree that information obtained or generated through the application of this Cooperation Agreement shall be treated as sensitive and shall not be disclosed unless the Parties mutually decide otherwise; in accordance with the national legislation in force in Peru and the United Kingdom, including that relating to intellectual property.

Article 9 Legal Nature

This Agreement shall be applied in accordance with the legal framework in force in each country, and establishes common rules by virtue of which joint work shall be carried out between the Parties, within their sphere of competence.

This Cooperation Agreement does not create any financial rights or obligations between the Parties.

Article 10 Validity and modification

This Cooperation Agreement shall be effective from the date of its signature by the Parties and shall be in force for three (3) years, unless a Party notifies its counterpart in writing of its intention to terminate it. The termination of this Agreement will not affect the development and completion of the interventions initiated while it was in force.

The Parties may jointly amend the content of this Cooperation Agreement and decide on new areas of cooperation, without prejudice to the application or integrity of this document. Such modification must be made by means of an Addendum, which must be in writing and signed under the same modality and with the formalities that this Agreement is signed.

The renewal of the Agreement shall be subject to the interest of the Parties and the achievements obtained, and must be requested and supported by the respective coordinator, before the end of its validity.

ANNEX I

Specific topics within the framework of the areas of cooperation defined in Article 2 of the Cooperation Agreement

Bioeconomy:

- Scaling up biobusinesses from the conservation of standing forests with a focus on the Amazon.
- Promote the value chains of products such as aguaje, chestnut, camu-camu, macambo or others that are priorities.
- Promotion of spaces for public and private coordination for the development of ecos and biobusinesses, promoting solutions around access to markets, financing, as well as improving the applicable regulatory framework.
- Strategic framework for the promotion and development of the Bioeconomy in Peru that promotes the mobilization of investments and incentives.

Green finance:

- Organization of high-level events in green finance, such as the International Forum on Green Finance, among others.
- Consolidate a platform of actors with the purpose of structuring a portfolio of projects that mobilize resources at the national level.
- Promotion and technical assistance to develop and implement instruments for biodiversity and climate change financing that can be identified by Parties.

Sustainable Infrastructure:

- Promote infrastructure solutions with a focus on the energy transition (e.g. renewable energies, land, river and rail transport), as well as for the integrated management of natural resources.

Joint Declaration of Intent:

- Halting and combating deforestation, strengthening mechanisms for the conservation and valuation of standing Amazon forests.
- Cooperation to assess participation in high-level platforms and coalitions that seek to reduce and reverse forest loss and land degradation by 2030, such as the LEAF Coalition (Lowering Emissions by Accelerating Forest Finance coalition), the FCLP, and FACT, among others.
- Strengthening of multilevel, multisectoral and multi-stakeholder governance, through coordination platforms such as the DCI, as well as its financial mechanisms, to ensure the sustainability of ecosystems and their ecosystem services, through the articulation of conservation interventions, and management of natural resources in the context of climate change.
- Cooperation to strengthen the implementation of REDD+ safeguards with an emphasis on respect for indigenous peoples in the Amazon and transparency of information, promoting high integrity.
- Dissemination, awareness-raising, and capacity building for the involvement of citizens, indigenous populations, and the private sector in climate action.

Conservation of biological diversity:

- Promotion of initiatives that contribute to the implementation of the global targets of the Kunming-Montreal Global Biodiversity Framework, with emphasis on targets 2, 3, 13, 15, 18, 19 and 20 and other agreements adopted in the framework of the Conferences of the

- Parties to the Convention on Biological Diversity related to the sharing of benefits derived from the use of digital information on sequences of genetic resources (DSI, in English).
- Promotion of strategic actions that contribute to the timely implementation of the National Biodiversity Strategy for 2050 and its financing plan, especially with the development of initiatives related to the financing of biodiversity conservation.
- Strengthening capacities for the involvement of citizens, indigenous populations, local communities, women and youth, and the private sector in the conservation and enhancement of biodiversity.



Climate Change Mitigation and Adaptation:

- Joint strategic actions that contribute to the implementation of the National Policy: National Strategy for Climate Change to 2050 and with the NDCs.
- Support in the finalization of Peru's registration document to apply to the ART Trees standard.
- Identification of barriers, alternatives or feasibility for the promotion and implementation of innovative instruments, such as the commercialization of carbon credits in the soil of Amazonian peatlands and other climate finance instruments.



Incentives for forest conservation:

- Promote forest conservation through the strengthening, design, and/or implementation of economic and financial mechanisms with special attention to the forests of the Amazon, considering high-integrity market schemes.



Prevention and reduction of environmental crime

- Prevent, reduce and coordinate the fight against environmental crimes and associated illicit flows, among other actions that contribute to the National Strategy for the Prevention and Reduction of Environmental Crimes or other initiatives in this area.
- Improve regional cooperation to address environmental crime through coordination with ACTO (Amazon Cooperation Treaty).
